- ✓ DO NOT enter an application number – this will be completed by the Town.
- ✓ Please provide a phone number, so we can call you with any questions.
- ✓ Provide a clear description of the location of the driveway access point in this form.
- ✓ Provide a map that clearly identifies the proposed access point, along with your tax parcel ID number.
- ✓ You MUST mark the proposed access point at the edge of the road with stakes and florescent tape.
- ✓ Please call the Road Commissioner if you have any questions (the Town Clerk can provide the number).
- ✓ If this is a permanent request, please include a check for \$57.00 payable to the Town of Jamaica.
- ✓ There are no fees for temporary requests.
- ✓ Return this form, map, and fees to the Jamaica Town Offices – PO Box 173, Jamaica, VT 05343.

IMPORTANT: You must not start construction of your driveway until this permit has been signed. Incomplete forms, or requests that don't have the proposed location marked with stakes will be returned. These requests are addressed by the Jamaica Selectboard at their regular meetings. Please plan accordingly.

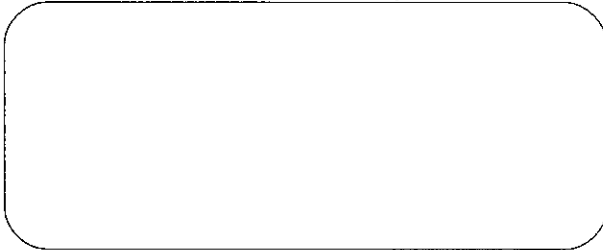

The permit will be effective upon compliance with such of these requirements as are applicable and unless an expiration date has been fixed, it will continue in effect for as long as the present land use continues. Any change from the present land use will require a new permit. *This permit is issued subject to the directions, restrictions, and conditions contained herein and any attachments hereto, and covers only the work described in the application accompanying this permit, and then only when the work is performed as directed.* Violations are subject to the penalties set forth in Title 19, Section 43, V.S.A. Of fines of not less than \$100, nor more than \$10,000 for each violation.
