- 2. Approve the minutes from the August 6 and September 14, Selectboard meetings August 6 minutes, Jessica was not there.

Tom made a motion to approve the minutes from September 14<sup>,</sup> 2020, seconded by Paul.

4. Update and discussion on R&R signs

John was unable to attend the meeting, but he forwarded an update to Greg. There has been no action on taking down the signs that are not in compliance.

Tom made a motion to instruct the sign administrator to enforce the sign ordinance as written and to fine each of the applicants that have not complied and to back date it to when the violations were identified by the sign administrator. Seconded by Paul. All in favor.

5. Review proposed False Alarm Ordinance from the Fire Department

Discussion on procedure for adopting an ordinance.

Greg suggested running it by the town attorney to make sure everything is correct. They would also like to ask the attorney for the next steps in the process of adopting the ordinance. Bob would like the ordinance to begin at the first of the year 2021.

Tom thinks Lou should present this to the board and would like to table it until he is available to answer questions.

7. *Update on Communication Union District and survey* Chris is not present, no update.

### 8. *Updates on town road paving projects*

Most of the paving projects are complete. The next step is to have the crosswalks painted. The state will repaint the lines, but they have not given us a date yet.

## 9. Discuss installation and locations for electronic speeding signs

The speed signs have arrived, the permit has been submitted to Vtrans for the ones on Route 30. Greg would like to form a committee to decide where to put the signs, including Keith the Road Foreman and Lexa the Road Commissioner. Paul and Tom will be a part of the committee unless someone else wants to be on the committee.

There have been complaints of kids playing in the road, putting up cones and not paying attention to traffic. Parents need to take responsibility for children, it is extremely dangerous. Paul would like to bring the families together to have a conversation, saying here is what we have done to slow people down now what can you do to keep your children safe?

## 10. Discuss banner location and signage

It has been difficult to find a place to put the banner. It could be hung across the road but it can not be attached to utility poles. It is still undetermined where it can be placed.

### 11. Discuss hiring of Transfer Station Alternate

One person found a full-time job, they spoke with one person and the third person never got back to them. The conversation will be moved to executive session. Bill is available to work again.

#### 12. Hamilton Falls update

There was a meeting with the Department of Forest, Parks and Recreation at Hamilton Falls. Members of the community and Selectboard members attended. The parking has been reduced to four spots and if they are full, people should enter through the state park. The sheriff's department is patrolling the area on the weekends.

Charlie Peck asked if the town wants to rewrite the parking ordinance. He has offered to do it. Greg will talked to Charlie about this.
