Greg called the meeting to order at 7:00 p.m.

- 1. Call for any late additions to the agenda

- 2. Approve the minutes from the March 1st and 8th, Selectboard meetings

7A. Fire Department Cistern presentation by Bob Stomski

Funding is the main issue; it will cost \$50,00 to \$90,000 to have it installed.

Paul suggested that a bond may be an option to pay for it. The idea will be discussed at Town Meeting.
