## **Old Route 8 Road River Embankment Restoration Project RFP**

1. Ameden Construction - \$130,000

2. Hunter Excavation – \$141,000

3. Fitzpatrick Excavating - \$97,500

4. AS Clark Construction: \$112,260

Resolution to Accept the RFP cost proposal from Fitzpatrick Excavating quote in the amount of \$97,500 to perform the work related to the Old Route 8 Road River Embankment Restoration Project.

Discussion: It was acknowledged that all contractors submitting cost proposals have been referenced as the local experts with experience working in streams and working with the River Engineer on repair projects related to storm impacts.

## **Old Route 8 Road Uphill Slope Stabilization Project RFP**

- 1. Ameden Construction \$110,000
- 2. Hunter Excavation \$52,000
- 3. Fitzpatrick Excavating \$18,000

Discussion: The Chair asked if there were any concerns accepting the low bid. It was referenced that the contractor may be exposing themselves to a certain amount of risk with bids that fall substantially below other contractor bid proposals for the same work.

Resolution from Jessica Pollack to Accept the Cost Proposal from Fitzpatrick Excavating in the amount of \$18,000 to perform the work related to the Old Route 8 Road Uphill Slope Stabilization Project with the proviso the cost proposal submitted is indeed consistent with the scope of work referenced in the RFP. If there is a mismatch between the work proposed by Fitzpatrick Excavating and the Town of Jamaica RFP, then the bid submitted by Hunter Excavating in the amount of \$52,000 shall be accepted.

## **Goodaleville Road Embankment Restoration Project RFP**

1. Ameden Construction - \$96,000

- 2. Hunter Excavation \$125,000
- 3. Fitzpatrick Excavating \$42,450
- 4. AS Clark \$47,600

Discussion: Concern whether Fitzpatrick Excavating can perform the necessary work on the Goodaleville Road Bridge, when the two awarded emergency projects will take a significant amount of time to address. Ideally these emergency projects are to be completed by the end of November, where the state River Engineer can halt all project work until the spring, if weather conditions become too severe. It was proposed to award the project to the second lowest bidder to help expedite these emergency project by the end of the month or sooner. The difference between the proposal submitted by Fitzpatrick Excavating and AS Clark were very close to one another and AS Clark's work on a similar project at Pikes Fall Road shows their expertise with this specific type of storm damage repair.

There was also discussion whether AS Clark could perform the work before the end of the year. It was recommended that a similar resolution to the Old Route 8 Road Uphill Slope Stabilization Project should be entertained in the approved decision.

Resolution by Greg Meulemans to Accept the Cost Proposal from AS Clark in the amount of \$47,000 to perform the work related to the Goodaleville Road Bridge Approach and Embankment Restoration Project. It was further stated, if AS Clark cannot do this emergency repair project this year, the cost proposal submitted by Ameden Construction in the amount of \$96,000 would be accepted.
